COURSE DESCRIPTION

Credit Hours: 3

Prerequisite: None, but we recommend two years of high school algebra.

Special Note: High school students who earn a "3" or better on the AP Statistics exam will be given credit for STA 2023.

- A TI-84 Plus or equivalent calculator. We will teach you how to use a TI-84 series calculator, but we cannot promise to be able to help with any other type of calculator.
- A textbook is NOT required for this class. All required course notes and exercises will be provided.

The course covers statistical applications in business, involving graphical and numerical descriptions of data, data collection, correlation and simple linear regression, elementary probability, random variables, Binomial and Normal distributions, sampling distributions, and confidence intervals and hypothesis tests for a single sample.

The purpose of this course is to prepare students for further study and job preparation in the field of Business. It will emphasize understanding of data and interpretation of statistical analyses. It will require students to think of data, and report the results of their analyses, in context.

Lecture Videos: As the course is asynchronous, no live lectures would be performed; instead, lecture notes and lecture videos will be uploaded. Watching lecture videos is equivalent to attending class and listening to lectures. If you find that you are unable to watch an entire video in one go, you are encouraged to take a break and return to it later. Pause whenever you need to, but <u>always be sure to return and finish watching the video</u>.

COURSE OBJECTIVES

This course has been approved to meet FSU's **Liberal Studies Quantitative and Logical Thinking** requirements and is designed to help you become a critical analyst of quantitative and logical claims. In order to fulfill the State of Florida's College mathematics and computation requirement the student must earn a "C-" or better in the course.

By the end of the course, students will demonstrate the ability to:

- 1. Select and apply appropriate methods (i.e., mathematical, statistical, logical, and/or computational models or principles) to solve real-world problems.
- 2. Use a variety of forms to represent problems and their solutions.

The above two competencies will be assessed in the Liberal Studies Quantitative Assessment (LSQA) for STA 2023, which includes a written summary of results. The LSQA forms a mandatory ten percent of the course grade. If you do not take it, you will not be permitted to pass the class, regardless of how well you perform on the other assessments. The LSQA will be an online assessment graded for accuracy; two attempts will be allowed; collaboration is not permitted; no internet sources are allowed apart from the course Canvas.

- 3. Use descriptive statistics and graphical methods to summarize data accurately.
- 4. Use inferential statistics to make valid judgments based on the data available.

- 5. Describe the goals of various statistical methodologies conceptually.
- 6. Apply statistical techniques in the context of business processes, everyday life, and further studies in their discipline.
- 7. Develop a healthy skepticism toward statistical studies and their results based on a sensible consideration of the techniques employed.

- 1. All the assessments will be online, through Canvas.
- 2. All the assessments will have different time limits, which will be communicated before each assessment.

- 3. There will be **6 Quizzes** and **1 Final Quiz**. The lowest graded quiz among the first **6 Quizzes** will be dropped at the end of the semester. The **Final Quiz** will NOT be dropped. The topics covered in each quiz will be communicated beforehand. You will get two attempts in each quiz, and the higher score will be kept.
- 4. There will be 1 Liberal Studies Quantitative Assessment (LSQA), which will cover only one topic. The topic will be communicated accordingly. LSQA is mandatory to pass the course and will NOT be dropped. You will get two attempts, and the higher score will be kept.
- 5. There will be **4 homework assignments** in total. The topics covered in each homework assignment will be communicated accordingly. You will get unlimited attempts, but ONLY the last attempt will be graded.

Instructions: Final instructions will be given prior to each assessment, but in general you must follow the instructions below.

- > TI-84 Plus (or equivalent) calculator is allowed. You can also use the TI Emulator (software version).
- ➤ All the assessments are open book, open material, and no online proctoring service will be used.
- ➤ Discussion or any kind of collaboration with other students for all the <u>Quizzes</u>, <u>Final Quiz</u> and <u>LSQA</u> is STRICTLY PROHIBITED.
- You can use scratch papers to solve problems, but you don't need to upload/send those scratch papers.

Additional instructions regarding homework assignments: Final instructions will be given prior to each homework assignment, but in general you must follow the instructions below.

- > Discussion is allowed ONLY for homework assignments. You are strongly encouraged to work together with your classmates in this class.
- All homework assignments are required to be submitted individually and NOT in groups.
- ➤ Please avoid plagiarism. It means, you can discuss/work on a problem with your classmates, but your answer should NOT exactly be same. You should have your own words to write an answer.
- You will get unlimited attempts to submit homework assignments, but **DO NOT** submit multiple files as one attempt. In one attempt, your submission should consist of **a single file** with the entire assignment. It means, you should NOT submit one file with the first half of the assignment and a second file with the other half of the assignment. If you do so, those will be considered as multiple attempts and only the latest one will be graded.
- > If you take multiple valid attempts, then ONLY the latest attempt will be graded.
- > The homework assignments can only be submitted in Microsoft Word or PDF format.

Technology-dependent Assessments: This course is heavily technology dependent. While we will do our best to work with you on technology issues, please be aware that if you submit an assessment but we don't find absolutely no record of the fact, then we will not be able to give you credit for it. Please **DO NOT USE SAFARI** when you take assessments on Canvas, please **USE Chrome** or **Firefox**.

Completing assessments in a timely manner so that you can stay on track:

Please note that missed assessments need to be completed in order. Therefore, an extension on a specific assessment will not be granted if you have prior outstanding assessments. For example, if you request an extension

on Assessment 8 but you did not complete Assessment 3, then you will be denied an extension on Assessment 8 but you may receive an extension on Assessment 3. The last day of classes will be the deadline for all assessment submissions, including assessments where extensions were granted, but not including the final assessment. In addition, since this is a semester-long college course, designed to be taken one step at a time throughout the semester rather than hurriedly over the span of a few days, or a few weeks, we will not allow extensions on due dates during the last two weeks of classes unless you have completed at least eighty percent of the assessments given up to that point, including the LSQA. For example, if the LSQA and nine other assessments have been given by the start of the last two weeks of classes, then you will need to have completed the LSQA and at least seven other assessments in order to receive any extensions on due dates during the last two weeks of classes.

Your overall percentage will be calculated according to your assessment grades (reported as percentages) and the weights given to those assessments. Your letter grade will be assigned using the table above by rounding the overall percentage to the smallest whole number greater than or equal to that (e.g., an overall percentage of 89.01% will be assigned an A- since 90% is the smallest whole number greater than or equal to 89.01%).

No make-ups, no extra credit assignments, no curving grade, and in general, no opportunities for grade improvement will be allowed after the Last Day of Class. So, please submit every assessment on time and do your best throughout the term. **Assessments that are not submitted will receive a grade of zero.** These will be replaced with earned grades if make-ups of the same are submitted later.

Assessment Grade Appeal: During the term, if you believe that an assessment has been improperly graded, then you must e-mail me and discuss it with me within 2 working days after your grade for that assessment is posted on Canvas. If you get an answer wrong in an assessment and believe that you may be right, you are allowed to discuss the question, the correct answer, and your justification with me. The problem will be reviewed and if you are correct, you will receive points back for that question. If I do not hear from you within 2 working days, I will assume that the grade is accepted and subsequent requests for a grade appeal may not be granted. Assessment grade appeals will not be allowed after the Last Day of Class.

Missing Grade: Please check your grades on the course website every day to make sure your latest grades are posted; please do this even if you already know your grade. If a grade is not posted, alert me immediately via email. It is important that you inform me via e-mail so that there is a record of the fact that you reported the matter. If you report a missing grade within 2 working days after the grade is posted, I will do my best to locate the missing grade.

Receiving a grade of "Incomplete": A request for a grade of "Incomplete" will

- ➤ **NOT be granted** if you have completed the coursework, including the assessments that cannot be dropped, and excluding the drops and allowable absences.
- **be granted** only if both of the following conditions are satisfied:
 - a) the only assessment that you have yet to take is the Final Quiz, and
 - b) your overall percentage excluding the Final Quiz is a passing grade (70% or above).
