• COURSE DESCRIPTION

Credit Hours: 3

- Prerequisite: None, but we recommend two years of high school algebra.
- Special Note: High school students who earn a "3" or better on the AP Statistics exam will be given credit for STA 2023.

The course covers statistical applications in business, involving graphical and numerical descriptions of data, data collection, correlation and simple linear regression, elementary probability, random variables, Binomial and Normal distributions, sampling distributions, and confidence intervals and hypothesis tests for a single sample.

The purpose of this course is to prepare students for further study and job preparation in the field of Business. It will emphasize understanding of data and interpretation of statistical analyses. It will require students to think of data, and report the results of their analyses, in context.

• LEARNING OBJECTIVES

This course has been approved to meet FSU's Liberal Studies Quantitative and Logical Thinking requirements and is designed to help you become a critical analyst of quantitative and logical claims. In order to fulfill the State of Florida's College mathematics and computation requirement the student must earn a "C-" or better in the course. By the end of the course, students will:

- 1. Select and apply appropriate methods (i.e., mathematical, statistical, logical, and/or computational models or principles) to solve real-world problems.
- 2. Use a variety of forms to represent problems and their solutions. The above two competencies will be assessed in the Liberal Studies Quantitative Assessment for STA 2023, which includes a written summary of results.
- 3. Use descriptive statistics and graphical methods to summarize data accurately.

- 4. Use inferential statistics to make valid judgments based on the data available.
- 5. Describe the goals of various statistical methodologies conceptually.
- 6. Apply statistical techniques in the context of business processes, everyday life, and further studies in their discipline.

7. Develop a healthy skepticism toward statistical studies and their results based on a sensible consideration of the techniques employed.

• TEXTBOOK INFORMATION

 Purchasing the textbook is NOT mandatory.

• REQUIRED MATERIALS

- The class will be taught remotely, asynchronously. Listening to the class videos from the course website, and participation by asking and answering questions in person or on discussion boards is important. A student will be responsible for everything is covered in the class videos. It is expected that the students approach the instructor with any questions they have after listening to a lecture video.
- A graphing calculator, preferably a TI-84. **Use of calculator is mandatory.** Students will need to use a calculator starting week 3, and it should be arranged accordingly.
- Access to Canvas course website is mandatory. All the homework assignments and course material will be uploaded on the course website. Important announcements will be made via the course website as well. It is a responsibility of the students to check the course websites for any updates every day. It is advised that students should turn on the applicable notification settings on your Canvas course site so that they don't miss anything.

- Homework Assignments:

- * Homework assignments will be announced on Canvas course website.
- * Homework assignments are open assessments, which means that you can discuss the homework with your classmates, but each student must submit his/her own work.
- * Late submissions will not be accepted unless arrangements have been made with the instructor **prior to the due date**.
- * Lowest homework grade will be dropped during the final grade calculation.

- Liberal Studies Quantitative Assessment (LSQA):

As noted in the course objectives, this course has been approved to meet FSU's Liberal Studies Quantitative and Logical Thinking requirements and is designed to help you become a critical analyst of quantitative and logical claims.

Liberal Studies Quantitative Assessment (LSQA) will assess you for the first two course objectives. The assessment will be administered during weeks 7-10 of the semester. The topics will be announced later.

- Exams:

- * Exams 1 and 2 will be scheduled in week 6 and week 11 tentatively.
- * Final exam will be available in the Finals week. It will be administered online.
- * You will need access to TI-84 or equivalent calculator for the exam.
- * All the exams will be open book/ open notes and would allow 2 attempts.

 Exams will be "open-book" which means that the following resources may be used during quizzes: class notes, homeworks, personal notes (these are notes that you can take while preparing/studying for quizzes), textbooks.

 Resources that may not be used during quizzes any and all people (including classmetes).
 - Resources that may not be used during quizzes: any and all people (including classmates etc.), the internet
- * Exams are mandatory for passing the course. A make-up can be scheduled for missed exams due to technical issues. It is a responsibility of student to let the instructor know if he/ she is going to miss the exam due to foreseen unavailability of network/ essential technology, so that make up can be arranged. If a technical issue arises while the exam is in progress, please let the instructor know immediately to avoid further complications.

- Class Participation:

- * A class engagement quiz will be available every week, which is in place to keep a track of your regular engagement in class. These quizzes will be based on lecture videos and will contain easy multiple choice questions/ open ended questions that can be answered easily if you have listened to the video attentively.
- * Class participation points will also be awarded for participating in the discussion boards by asking as well as answering questions, or asking questions in person.
- Extra Credit: Extra credit assignments are possible. These assignments will be announced via Canvas.

I acknowledge that the lecture videos are not short, but remember that class time would have been 50 or 75 mins not short either. On the bright side, however, you may pause the video at any time and return to it later you would not have been able to do that with live lectures. Therefore, I fully expect you to watch the lecture videos in their entirety. Pause whenever you need to, but always be sure to return and finish watching the video.
- Make sure to ask any doubts / questions and discuss it with me till the point of clear understanding. As it is rightly said, "He who asks a question is a fool for five minutes; he who does not ask a question remains a fool forever."
- Go through the topics covered in lecture videos and practice numerical examples in spare time on your own.
- Complete the assignments in timely manner. If you ask for help from your friends or from me, make sure you understand the solution before you submit it.
- Participate in the class. Ask questions on the discussion boards, answer other students'
 questions. Now that we are not going to meet in person, class participation is more important
 than ever.
- I encourage talking to your classmates when possible (except for exams and LSQA) to benefit from each others understanding.
- Plan your studies during the semester, so that one is prepared for the exams in timely manner without unnecessary stress.
