- **Homework:** There will be regularly assigned homework problems, but these will not be collected. There will be quizzes (mentioned below) which test the understanding of the homework exercises.
- **Grading:** Your grade will be based on quizzes (number to be determined) and three exams. The problems on the quizzes will closely resemble homework exercises or items from the assigned reading.

Your final course total will be a weighted average of your quiz average and your test scores, with a weight of 28% on the quiz average, and weights of 24% for each of the tests. The exams are **not** cumulative (except in the sense that the material is naturally cumulative). The initial grade cutoffs are 93.0% for A, 90.0% for A–, 87.0% for B+, 83.0% for B, 80.0% for B–, 77.0% for C+, 73.0% for C, 70.0% for C–, 60.0% for D. The actual grade cutoffs could be **lower** than this, if warranted by the distribution of scores.
