Course Description

- This course covers statistical applications in business, involving graphical and numerical descriptions of data, data collection, correlation and simple linear regression, elementary probability, random variables, Binomial and Normal distributions, sampling distributions, and confidence intervals and hypothesis tests for a single sample.
- The purpose of this course is to prepare students for further study and job preparation in the field of Business. It will emphasize understanding of data and interpretation of statistical analyses. It will require students to think of data, and report the results of their analyses, in context.

Learning Objectives

This course has been approved to meet FSU's Liberal Studies **Quantitative and Logical Thinking** requirements and helps you become a critical analyst of quantitative and logical claims.

In order to fulfill the State of Florida's College mathematics and computation requirement the student must earn a "C–" or better in the course.

By the end of the course, students will demonstrate the ability to:

1. Select and apply appropriate methods (i.e., mathematical, statistical, logical, and/or computational models or principles) to solve real-world problems.

2. Use a variety of forms to represent problems and their solutions.

The above two competencies will be assessed in the Liberal Studies Quantitative Assessment (LSQA) which includes a written summary of results. The LSQA forms a mandatory ten percent of the course grade. If you do not take it, you will not be permitted to pass the class, regardless of how well you perform on the other assessments. The LSQA will be an online assessment graded for accuracy; two attempts will be allowed; collaboration is not permitted; no internet sources are allowed apart from the course Canvas.

- 3. Use descriptive statistics and graphical methods to summarize data accurately.
- 4. Use inferential statistics to make valid judgments based on the data available.
- 5. Describe the goals of various statistical methodologies conceptually.

6. Apply statistical techniques in the context of business processes, everyday life, and further studies in their discipline.

7. Develop a healthy skepticism toward statistical studies and their results based on a sensible consideration of the techniques employed.

Required Materials

- A personal computer, reliable internet connection, and Chrome or Firefox browser.

- A TI-84 Plus or equivalent calculator. We will teach you how to use a TI-84 series calculator, but we cannot promise to be able to help with any other type of calculator.

Completing assessments in a timely manner so that you can stay on track

This is a semester-long college course, designed to be taken one step at a time throughout the semester rather than hurriedly over the span of a few days, or a few weeks. We will therefore not allow extensions on due dates during the last two weeks of classes unless you have completed at least eighty percent of the assessments given up to that point, including the LSQA. For example, if the LSQA and nine other assessments have been given by the start of the last two weeks of classes, then you will need to have completed the LSQA and at least seven other assessments in order to receive any extensions on due dates during the last two weeks of classes. Please note that the assessments need to be completed in order. Therefore, an extension on a specific assessment will not be granted if you have prior outstanding assessments. For example, if you request an extension on Assessment 8 but you did not complete Assessment 3, then you will be denied an extension on Assessment submissions, including assessments where extensions were granted, but not including the final assessment.

Grades

Assessments that are not completed will receive a grade of zero. When a makeup is completed, the zero will be replaced with the earned grade. If you believe that the grade you received on an assessment is incorrect, please bring it to my attention within two work days after the grade has been made available to you. If no issues are raised during that time frame, then it will be assumed that the grade is accepted and subsequent requests for a grade review may not be granted.

Notes About Exams:

- For exams, one <u>physical</u> note sheet (8" x 11.5" piece of paper, front and back, handwritten or typed), your calculator (physical or digital on your laptop, not your phone), and something to write with is allowed. Then note sheet must be a physical note sheet and not on your laptop.
- If you have a digital TI-84, you may bring your laptop in class to use during the exam. The computer must either have the Wi-Fi disabled or be in airplane mode so that no communication is allowed. Ultimately, it is your responsibility that no communication is available during the exam.
- Exams will generally have bonus points, but a maximum of 100 points can be achieved per exam.
- If classes get cancelled, exams may be moved online and treated as a take-home exam.

Late assessments:

- For open quizzes, 10% will be taken off each day the open quiz is late, up to 5 days (max 50% if 5 days late). There will be no additional penalties added for each day late after 5 days.
 - A student may request an extension if they know they cannot complete it on time. An extension is not guaranteed and is at the discretion of the instructor if an assessment can be made-up for full credit.
 - The open quizzes will be open until the last day of classes. All quizzes must be completed by then.
- For exams, make-ups will only be allowed if there is a documented excuse or there is advance notice from the student (if advance notice is given, it is up to the discretion of the instructor if a make-up will be granted).
 - If you know you cannot come to an exam, please contact the instructor as soon as possible, ideally in advance of the exam.
 - If an exam is missed for any undocumented excuse, a grade of 0 will be inputted and cannot be made up.
- For the closed quizzes, extensions will be allowed for documented excuse or at the discretion of the instructor. Otherwise, 10% will be taken off each day the quiz is late, up to 4 days. After 4 days, the quiz will close and not be available to complete.

Classes Subject to HB233 Recording
